Parent Update 17/06/21

Dear Parent/ Carer,

Testing

We would like to thank you again for your continued support with Covid-19 LFD home testing. Wherever possible, your child should **continue testing and reporting results twice a week** at home, more importantly given that the number of cases is on the rise again.

Positive Result - If your child tests positive, everyone in the household and any support bubbles your child is part of should self-isolate immediately in line with NHS Test and Trace guidance for 10 days. *Please inform school as soon as possible.*

You should order a confirmatory PCR test as the test was done at home. You can book a PCR test here. If the PCR test is negative, it overrides the LFD home-test result.

Void Result - If the result of the test is unclear (void) you should do another test. If the next test is also void, your child should take a PCR test. Negative and void results should still be reported to NHS Test & Trace.

Negative Result - A negative result does not guarantee that your child is not carrying the virus. Therefore, your child should continue to follow social distancing and other measures to reduce transmission, such as wearing a face covering and regularly washing hands.

If your child or anyone in your household gets symptoms of the virus, you should follow national guidelines on self-isolation and testing.

Around 1 in 3 people with Covid-19 do not have any symptoms but can still pass it on. The aim of the rapid testing is to test as many people as possible to help stop the spread of infections. Therefore, the government is encouraging all adults to participate in twice weekly testing to help stop the spread of coronavirus. Unfortunately, we have had reports from local residents that some students are disposing of these kits around the community, on their way home. Please note that these kits can be traced back to your child and appropriate action will be taken if any student is found to be disposing of their testing kit irresponsibly.
